Dear Parent/Guardian,

### **Who is eligible to apply for free school meals/school uniform/physical education allowance?**

Parent(s)/Guardian(s) who live in Northern Ireland, whose child/children attend a school or Regional/FE College in Northern Ireland and who receive one of the following benefits -

- Income Support;
- Income Based Jobseeker's Allowance;
- Income Related Employment and Support Allowance;
- Guarantee Element of State Pension Credit;
- Child Tax Credit or Working Tax Credit with an annual taxable household income of £16,190 or less;
- Universal Credit with net household earnings not exceeding £14,000 per year; **or** where the parent/guardian is an Asylum Seeker supported by the Home Office Asylum Support Assessment Team (ASAT)

As a school we are here to support you. Do not hesitate to contact me if you need any information or help. I cannot wait to welcome our new pupils to St. Mary's Primary School in September 2022!
